



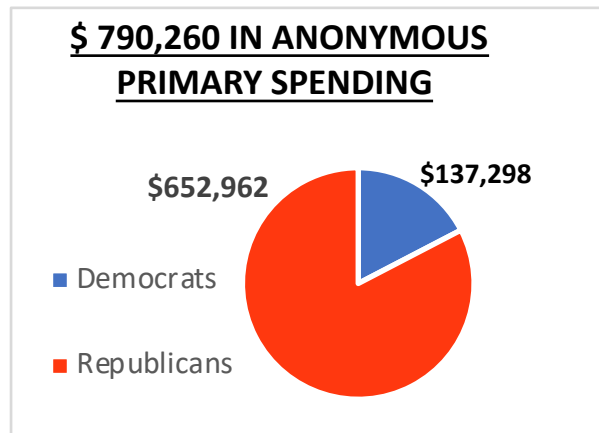
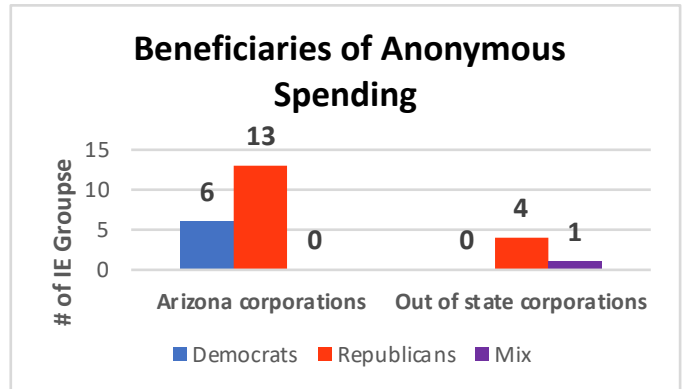
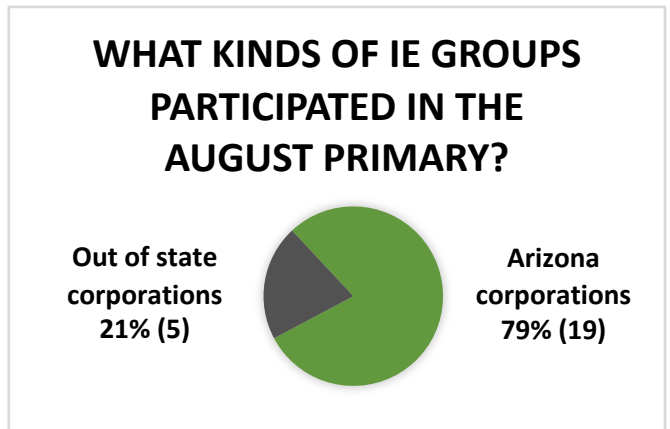
DIRTY MONEY IN THE 2018 ARIZONA PRIMARY

Most of us, when we contribute to a candidate or political party or PAC, are required to disclose our name and contact information. However a few business entities in Arizona have an exemption that permits them to spend unlimited amounts on political campaigning without disclosing their donors. We call that **DIRTY MONEY!**

A few groups in the exempt category (some advocacy groups and unions, for example), do not oppose reporting their donors. We applaud them. However, most entities that don't have to disclose were organized specifically to funnel anonymous contributions to support or oppose candidates or ballot initiatives. (We are working to identify those that do and do not support disclosure. More info in coming weeks...)

State election financing is tracked by the Secretary of State (SOS). The following analysis is based on reported spending by "**Independent Expenditure**" groups – all of which are dirty money sources that are NOT required to report who their donors are. *The information below represents organizations classified as Independent Expenditure (IE) groups that reported activity running up to the primary. It includes Arizona statewide and legislative races. We will update our information as it is reported throughout the fall. This analysis does not include federal Senate or House races, which are reported at the Federal level. (We are in the process of gathering the federal level data.)*

24 Independent Expenditure (IE) organizations participated in our primary activities. **21% (5/24) of participating IE groups were from out of state.** The others are registered as Arizona corporations with the Arizona Corporation Commission.



Dirty money was used to support both Republican and Democratic candidates. **79% (19/24) of IE's were involved in Republican races, accounting for 82% of the total anonymous spending.**
