Re: Opposition to SB 1457 (abortion; unborn child; genetic abnormality)

## Legislators:

We are writing on behalf of the Arizona Medical Association (ArMA), the Arizona Section of American College of Obstetricians and Gynecologists (AzACOG), the Arizona Academy of Family Physicians (AzAFP), the Arizona Chapter of American Academy of Pediatrics (AzAAP), the Arizona Osteopathic Medical Association (AOMA) and the thousands of Arizona physicians that these organizations collectively represent. We urge you to oppose SB1457, which criminalizes the termination of pregnancy based upon a genetic abnormality. The conference committee amendments do not alleviate the significant harm that the bill poses to the physician-patient relationship and medical care in Arizona.

Our organizations stand in strong opposition to any legislation that criminalizes the practice of medicine, which SB 1457 undoubtedly does. If enacted, SB 1457 would subject physicians providing legitimate medical care to their patients to felony charges. It will likely result in patients seeking abortion care from unlicensed providers, thereby risking their health and safety. Government should not be in the business of defining appropriate medical care and should not be regulating the practice of medicine through criminal sanctions.

In addition, SB 1457 severely compromises the physician-patient relationship which is the basis for high quality medical care. The bill will discourage communication between physicians and patients by creating a fear of criminal prosecution. The physician-patient relationship is founded on trusted, open and honest communication, which best serves the health and safety of the patient and ensures that the physician is able to make the most informed medical judgment. SB 1457 undermines the foundation of the physician-patient relationship by threatening criminal consequences. This is bad public policy that does not serve the best interest of Arizonans.
